

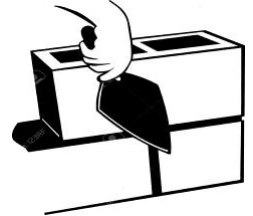
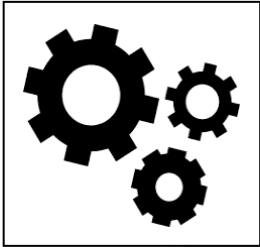

CERTIFICATIONS

All vocational trades are issued a certificate from the State of Michigan stating which specific tasks are completed and the number of hours trained for the class. Students will also complete course work and hands on exercises to obtain a Powered Industrial Truck Operators permit (Forklift).

Building Trades-Earn NCCER Certification and OSHA 10 hour card.

Auto Mechanics- up to 8 different State of Michigan mechanic licenses.

CNC Machine/Robotics- 4 certificates issued from immersive software recognized by HAAS. FANUC Robotics certificate.

Masonry- Earn NCCER certification and OSHA 10 hour card.

CDL- Earn a Temporary Instruction permit and virtual instruction in various scenarios and road conditions.
